1. This Invitation for Bids follows the General Procurement Notice (GPN) for this project that appeared in UNDB online on 31st March 2017.
2. The Athi Water Services Board has received Financing from the African Development Bank in various currencies towards the cost of Kenya Towns Sustainable Water Supply and Sanitation Program. It is intended that part of the proceeds of this loan will be applied to eligible payments under the contract for construction of Kiambu and Ruaka Water Supply & Sewerage Project.
3. The Athi Water Services Board now invites sealed bids from eligible bidders for the execution of the following works:

a. Kiambu and Ruaka Sewerage Works

- i. Rehabilitation of existing STW;
- ii. Rehabilitation existing problematic sewers;
 - Trunk Sewers DN450 PCC in m as; (Riara River, Kiu River, Kiu outfall, Riara River Branchtrunk, Thindigwa Kasarani River, Ruaka River, Ndenderu, Thindigwa Kigwa River, Githogoro trunk) Totalling approximately 55Km.
 - Lateral Sewers DN300 Upvc in m as; (Kiambu Town reticulation, Ndumberi reticulation Kirigiti reticulation, Ruaka & Mucatha reticulation, Mugumo reticulation, Kiamumbi reticulation, Thindigwa Reticulation, Kanda Komu reticulation) totaling approx. 53Km
- iii. Construction of 4 No ablation blocks for Kiambu and Ruaka.

b. Water Supply Works

- i. Water Distribution lines Upvc ranging from DN 50 to DN 160, totaling approx. 25Km
- ii. Drilling and equipping of 6 Nr Boreholes for Kiambu Community point sources.
- iii. Kiameru RC Weir 6.5m high
- iv. Kigongo Water Treatment 4,000m³/d

c. The Rehabilitation Works will include:

- i. Replace existing aerator and add the missing aerator; Replace corroded sluice gate;
- ii. Rehabilitate existing building (electrical wiring and painting); Install new electrical control system;
- iii. Install new screw pump; 4 Unblock existing sewers;
- iv. Rehabilitate manhole including replacing of the manhole covers; New generator room;
- v. New Inlet Works; New sludge beds;
- vi. New settling tank (to demolish one of the dysfunctional existing settling tank).

6. The provisions in the Instructions to Bidders and in the General Conditions of Contract are the provisions of the African Development Bank Standard Bidding Document: Procurement of Works.
7. Bids must be delivered to the above office on or before 12.00pm East African Time on 25th May, 2018 and must be accompanied by a Security (Unconditional Bank Guarantee) of KShs. 10,000,000.00 (Kenya Shillings Ten Million Only). With a bid validity period of 120 days from bid submission date.
