The Government of Kenya has received financing from the Government of the Federal Republic of Germany and the European Union, through KfW Development Bank, to undertake the Nairobi City Water Distribution Network Modifications Project. The Project is being implemented by Athi Water Services Board, a parastatal under the Ministry of Water and Irrigation.

Athi Water Services Board now invites sealed bids from eligible bidders for Extension of Water and Sewerage Services in Peri-Urban and Informal Settlements – Lot 3(A). The Works consist of:

The Construction Period is **18 Months**.

Bidding will be conducted through the **International Competitive Bidding (ICB)** procedures as specified in the **KfW Guidelines for Procurement of Goods, Works and associated Services in Financial Cooperation with Partner Countries (May 2007 and updated in September 2013)**. The Guidelines can be downloaded from www.kfw-entwicklungsbank.de/International-financing/KfW-Development-Bank/Publications/Guidelines. Bidding is open to all eligible bidders as defined in the KfW Guidelines.

Interested eligible bidders may obtain further information from the address specified below and inspect the Bidding Documents during office hours from 8.00am to 5.00pm local time from Monday to Friday, except during lunch hour (1.00pm to 2.00pm), weekends and public holidays.

A complete set of Bidding Documents in English may be purchased by interested eligible bidders upon the submission of a written application to the address below and upon payment of a nonrefundable fee of **KSh. 1,000 (Kenya Shillings One Thousand only)** or equivalent in a freely convertible currency. The method of payment will be **Cash or Banker's Cheque**. The Bidding Documents will be collected from the address given below upon production of a purchase receipt.

A **mandatory** Pre-Bid Meeting and Site Visit will take place at the address specified below on **13th June, 2017 at 9.00 a.m. East African Time**. The Pre-bid Meeting and Site Visit is **compulsory** for any firm intending to submit a bid.

Bids must be delivered to the address below on or before **12 noon East African Time on 17th July, 2017**. The packages should be clearly marked; **Nairobi City Water Distribution Network Modifications Project: Extension of Water and Sewerage Services in Peri-Urban and Informal Settlements – Lot 3(A): Tender No. AWSB/KFW/NCD/W/03(A)/2017**. Electronic bidding will not be permitted. Late bids will be rejected. Bids will be publicly opened in the presence of the bidders' designated representatives and anyone who chooses to attend at the address below on **17th July, 2017 at 1205 hours East African Time**.

All bids must be accompanied by a bid security of **KShs. 9,000,000 (Kenya Shillings Nine Million)** or equivalent amount in Euro.
