1. This Invitation for Bids follows the General Procurement Notice (GPN) for this project that appeared in UNDB online on **31st March 2017**.
2. The Government of Kenya has received Financing from the African Development Bank in various currencies towards the cost of Kenya Towns Sustainable Water Supply and Sanitation Program. It is intended that part of the proceeds of this loan will be applied to eligible payments under the contract for Construction of Machakos Water Supply Works.
3. The Athi Water Services Board now invites sealed bids from eligible bidders for the execution of the following works under one contract:
 - **Construction of Miwongoni 15m high Earth fill Weir of storage capacity 2.0Mm³ and 600mm DN 600mm raw water gravity main**
 - **Construction of Miwongoni water treatment works of capacity 10,000m³/d , 18km long rising main steel pipelines, 2 Nr storage tanks of capacity 5,000m³ at Katelembu and 1,000m³ at Kiima Kimwe,**
 - **40km Gravity water transmission and distribution pipelines diameters 63-315mm within Machakos town, Mutituni, Katoloni, Kimutw'a, Chumvi, Muvuti and Kaseve.**
 - **Development of 10No. new boreholes and rehabilitation of 5No. existing boreholes**
 - **Rehabilitation of existing water treatment plant at Maruba and water supply networks**
 - **3,000 domestic water connections**
4. A Pre bid meeting and site visit will take place on **19th June 2018** starting from **10.00a.m** (East African Time) at Machakos Water and Sanitation Company Offices in Machakos Town along the Machakos-Kitui Road.

7. The provisions in the Instructions to Bidders and in the General Conditions of Contract are the provisions of the African Development Bank Standard Bidding Document: Procurement of Works.

Bids must be delivered to the above office on or before **12.00pm East African Time on 12th July 2018** and must be accompanied by a security (**Unconditional Bank Guarantee**) of **10,000,000.00 (Kenya Shillings Ten Million Only)** with a bid validity period of 120 days from bid submission date.
