1. The Athi Water Services Board has received funds from the Agence Française de Développement (the French Development Agency) towards the cost of improvement of sanitation network within Nairobi City. It is intended that part of the proceeds of these funds will be applied to eligible payments under the contract for construction of sanitation blocks in Nairobi informal settlements
2. The Athi Water Services Board now invites sealed bids from eligible bidders for construction of 15 no. Sanitation blocks in Nairobi informal settlements (Kibera Mathare, Korogocho, Mukuru, Kangemi, Kibagare, Kawangware and Kiambiu), referred to ("the Works")
3. Interested eligible bidders may obtain further information from and inspect the bidding documents at the office of **Chief Executive Officer, Athi Water Services Board, 3rd floor, Africa Re Centre Upper Hill, Nairobi.**
4. Complete sets of bidding documents may be purchased by interested bidders on the submission of a written application to the above and upon payment of a non-refundable fee of KShs. 1000 (Kenya Shillings One Thousand Only) for each lot. The method of payment will be cash or Banker's cheque. The document will be collected from the below address.
5. The provisions in the Instructions to Bidders and in the General Conditions of Contract are the provisions of the Agence Française de Développement's Standard Bidding Documents: Procurement of Goods.
6. Bids must be delivered to the above office on or before **12.00pm East African Time on 8th September, 2017** and must be accompanied by a bid security (**Unconditional Bank Guarantee**) of KShs. 1,000,000 (Kenya Shillings One Million Only).
7. Bids will be opened in the presence of bidders' representatives who choose to attend at **12.05pm East African Time on 8th September 2017** at the offices of:

8. Qualification criteria are as follows:
 - a) Certified copies of Certificates of statutory registration, Letter of registration with National Construction Authority or Equivalent (Level 7), VAT & Tax compliance certificates, Dully filled forms of Statement of Integrity, Dully filled forms of Eligibility and Social and Environmental Responsibility
 - b) Financial capability- Demonstrated average annual turnover of Kshs. 10 Million
 - c) Experience and Technical Capacity – the Bidder must have undertaken at least one (1) contract within the last Five (5) years, each with a value of at least Kenya Shillings Ten Million (KSh. 10,000,000) or equivalent in a freely convertible currency
 - d) The bidder shall provide documentary evidence that Goods offered meet the requirements stipulated in the specifications.
