1. The Government of Kenya has received financing from the Government of the Federal Republic of Germany and the European Union, through KfW Development Bank, to undertake the **Nairobi City Water Distribution Network Modifications Project**. The Project is being implemented by **Athi Water Services Board**, a parastatal under the Ministry of Water and Irrigation.
2. **Athi Water Services Board** now invites sealed bids from eligible bidders for **Construction of the Western Transmission (Kabete-Uthiru-Karen) Pipeline – LOT 2**. The Works consist of:
 - a) Construction of Water Transmission Pipeline from Kabete to Uthiru to Karen:- Ferrous Pipeline of sizes 500mm and 900mm diameter, approximate total length 12.55km comprising of the following sections:
 - i) **Kabete to Uthiru Pipeline**
 - ▣ DN 900mm ferrous pipeline, length 4.15km
 - ii) **Uthiru to Karen Pipeline**
 - ▣ DN 900mm ferrous pipeline, length 5.25km
 - ▣ DN 500mm ferrous pipeline, length 3.15km
 - b) Construction of Reinforced Concrete Water Storage Tank in Karen, capacity 5,000m³.
 - c) Electromechanical Works and associated Civil Works at the existing Kabete Pumping Station to upgrade the capacity of the Kabete-Uthiru Pumping System.

The Construction Period is **24 Months**

3. Bidding will be conducted through the **International Competitive Bidding (ICB)** procedures as specified in the KfW Guidelines for Procurement of Goods, Works and associated Services in Financial Cooperation with Partner Countries (May 2007 and updated in September 2013). The Guidelines can be downloaded from www.kfw-entwicklungsbank.de/International-financing/KfW-Development-Bank/Publications/Guidelines. Bidding is open to all eligible bidders as defined in the KfW Guidelines.
4. Interested eligible bidders may obtain further information from the address specified below and inspect the Bidding Documents during office hours from 8.00am to 5.00pm local time from Monday to Friday, except during lunch hour (1.00pm to 2.00pm), weekends and public holidays.
5. A complete set of Bidding Documents in English may be purchased by interested eligible bidders upon the submission of a written application to the address below and upon payment of a nonrefundable fee of **KSh. 1,000 (Kenya Shillings One Thousand only)** or equivalent in a freely convertible currency. The method of payment will be **Cash or Banker's Cheque**. The Bidding Documents will be collected from the address given below upon production of a purchase receipt.
6. A **mandatory** Pre-Bid Meeting and Site Visit will take place at the address specified below on **10th November, 2016 at 9.00 a.m. East African Time**. The Pre-bid Meeting and Site Visit is **compulsory** for any firm intending to submit a bid.
7. Bids must be delivered to the address below on or before **12 noon East African Time on 13th December, 2016**. The packages should be clearly marked; **Nairobi City Water Distribution Network Modifications Project: Construction of the Western Transmission (Kabete-Uthuru-Karen) Pipeline – LOT 2: Tender No. AWSB/KfW/NCD/W/02/2016**. Electronic bidding will not be permitted. Late bids will be rejected. Bids will be publicly opened in the presence of the bidders' designated representatives and anyone who chooses to attend at the address below on **13th December, 2016 at 1205 hours East African Time**.
8. All bids must be accompanied by a bid security of **KShs. 12,000,000 (Kenya Shillings Twelve Million)** or equivalent amount in Euro.
