- This Invitation for Bids follows the General Procurement Notice (GPN) for this project that appeared in UNDB online on **31st March 2017**.
- The Government of Kenya has received Financing from the African Development Bank in various currencies towards the cost of Kenya Towns Sustainable Water Supply and Sanitation Program. It is intended that part of the proceeds of this loan will be applied to eligible payments under the contract for Construction for Machakos Sewerage Works.
- The Athi Water Services Board now invites sealed bids from eligible bidders for the execution of the following works under one contract:
 - Construction of 1 No. waste water treatment plant capacity 12,500m³/day along River Ikiwe (trickling filter treatment system).**
 - Laying of 60km trunk and lateral Sewer lines within Machakos Town and Environs.**
 - Rehabilitation of the existing sewer networks**
 - Construction of 4 Nr. Sanitation blocks**
 - 2,000 individual sewer connections**
- A Prebid meeting and Site Visit will take place on **26th June 2018** starting at **10:00am (East African Time)** at Machakos Water and Sanitation Company Offices in Machakos Town along the Machakos-Kitui Road.
