1. This Invitation for Bids (IFB) follows the General Procurement Notice (GPN) for this Project that appeared in *United Nations Development Business online* UNDB online on 31st March 2017.
2. The Government of Kenya has received Financing from the African Development Bank in various currencies towards the cost of Kenya Towns Sustainable Water Supply and Sanitation Program. It is intended that part of the proceeds of this loan will be applied to eligible payments under the contract for Supply, Delivery and Installation of an Integrated Enterprise Resource Planning (ERP) System for Tanathi Water Services Board.

The ***Athi Water Services Board*** now invites sealed Bids from eligible Bidders for the Supply, Delivery and Installation of an Integrated Enterprise Resource Planning (ERP) System for Tanathi Water Services Board (hereinafter called "the Goods"). National Competitive Bidding will be conducted in accordance with the Bank's ***Rules and Procedures for Procurement of Goods and Works***.
